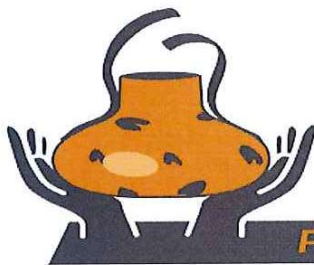


TVET SCHOLARSHIPS FOR 2025 - KERICHO COUNTY

 - (i) Certified copies of: -
 - (a) KCSE results' slip
 - (b) Secondary school leaving certificate.
 - (ii) Duly filled application form to Belgut Technical Training Institute
 - (iii) Duly filled Scholarship application form (incomplete forms will not be considered)
